



ASSOCIATE BUSINESS MEMBER APPLICATION

Q: Who can join as an Associate Business Member of the Federation?

Associate Business Members shall consist of any entity (corporate body) with 10 or less employees that is engaged in the provision of goods and services to golfers, golf course owners or their contractors, or the ownership, development, operation or management of golf courses.

Q: What does an Associate Business membership in the Federation entail?

Associate Business Members shall / may: -

- Have voting rights and rights to hold office on the Board, subject to the conditions stipulated in this Constitution.
- Have the right to use the term 'Member of Asian Golf Industry Federation' on all printed documents and communications, whether electronic or otherwise, in order to identify themselves as members of the Federation.
- Have the right to propose and second new Executive, Full Business, Associate Business and Golf Facility Members of the Federation.
- Be offered more than one corporate nominee per entity but only one vote per entity on any matter shall be allowed.
- May be appointed to chair or sit on any committee of the Federation.
- Have such other benefits as may be determined by the Board from time to time.

Q: What are the joining fees?

- Articles – One article every three months to be published on the AGIF website (4 articles per annum). Basic materials (text and images) to be provided by the member. Additional articles to be published at \$150 per article.

- BMI Asia Pacific / CMAA events: Member rate of US\$1,400 per five-day BMI module. Non-member rate is US\$1,600.



MEMBERS CODE OF BUSINESS ETHICS

The Asian Golf Industry Federation (the “AGIF”) is a not for profit organisation committed to help to develop the growth of golf in Asia.

As a regional grouping of industry stakeholders, the AGIF practises high business ethics within the organisation and in all its dealings with its Members and the golf industry. The AGIF does not engage in or condone any forms of unfair business practices.

Pursuant to clause 4 of the AGIF’s Constitution –

Members shall abide by all regulatory rules and laws applicable in the countries in which they operate and shall not engage in immoral, unethical or illegal activities (including without limitation, supporting vendors and trade shows who are engaged in such activities and counterfeiting, off label or unregistered use).

By becoming a member of the AGIF, each Member commits to practise good business ethics and not engage in any unfair, deceptive or misleading trade practices, especially of taking any action that restricts or tends to restrict competition in the golf industry.

As an AGIF Member, each Member commits to maintain the highest standards of business conduct and observe all regulatory rules and laws applicable in countries in which they operate.

Any Member found engaging in any illegal or anticompetitive activities or any activities which might reflect negatively on the international image of the AGIF may be admonished, suspended or expelled from the AGIF.
